## ASSIGNMENT OF ALTERNATIVE TO CASH DEPOSIT ASSIGNMENT AGREEMENT INSTRUCTIONS

Note: Please Read these instructions before completing the attached FORM

- 1. Certificates of deposit <u>must</u> be purchased from a federally insured <u>Arizona</u> bank, savings and loan association, or credit union.
- The certificate of deposit is to be <u>payable to the depositor</u> and delivered to the Registrar of Contractors <u>along with the complete and notarized Assignment Form</u>. (Depositor may be someone other than the contractor).
- 3. All certificates of deposit received and accepted MUST be continuously 'automatically renewable'.
- 4. The certificate of deposit will remain on deposit at the Registrar of Contractors as security for two years after <u>expiration, cancellation, or revocation</u> of the license, or for two years after the issuance of a surety bond to replace the cash security.
- 5. Sections #1 and #2 must be completed by the applicant. Section #3 must be filled out correctly and completely and signed by an officer of the bank, savings and loan association, or credit union, and must be notarized. The name of the 'contracting company' must read <u>exactly</u> the same as shown on the license application.
- 6. The assignment is signed in section #1 by the person the certificate is made payable to and section #2 is signed by the contractor (if different from the depositor).
- 7. The account number or certificate number on the assignment must correspond **<u>exactly</u>** to the number shown on the certificate of deposit.
- 8. Investment earnings are payable to the person designated by the depositor.
- **9.** After the assignment is completely filled out, signed and notarized per #5 AND #6 above, ALL copies are to be submitted to the Registrar of Contractors <u>along with the ORIGINAL CERTIFICATE OF DEPOSIT.</u>

### NOTE: Certificates of Deposit CANNOT BE SUBSTITUTED AT A LATER DATE.
